Multiunit zoning off Lyons Bend rejected by council

The Knoxville City Council heard and approved many zoning requests during its regular session Tuesday but turned down the request of Scott Smith for a multiunit development just off Lyons Bend Road along Northshore Drive.

Benjamin Mullins represented the developer and told the council that 15 acres were involved but that only two to five acres would be developed. He said the location, next to

a townhouse community, was unique to the area. The request was in three parts including the change in the Southeast Sector Plan with a request to go from low-density to medium-density residential. Scott Smith said no

more than 20 units would be planned and described the location as on a "beautiful cove."

Attorney Wayne Kline represented nearby homeowners and said much of the property is in a flood plain and watered by

A new school, road plans, merit changes heard by commission

The fairly brief meeting of the Knox County Commission last week seems to prove that the new meeting formats work and move things along quicker and easier. Separating the plan-

ning, agenda review, beer board and regular commission meetings into different days with earlier start times allowed the commission to sweep through the shortened agenda in about

Hardin Valley Road widening

Engineering Director Jim Snowden told the commission that \$2 million has been allocated for the first phase of widening Hardin Valley Road. The addition of two lanes to the current three-lane busy road west of Pellissippi Parkway was introduced with a video, featuring Snowden and Commissioners Kim Frazier and Terry Hill.

Snowden said the improvements over the next two years will greatly increase the capacity in Knox County's fastest- resolutions passed 10-0 growing community.

Two merit system changes

The commission approved two changes for the rules governing the Knox County Sheriff's Office Employees' Merit System; the first will forbid appeals on reclassification of jobs.

The second change opens appeals filed by employees on loss of pay on any suspension, changing the previous process that limited

appeals to suspensions of three days or more. Both with Richie Beeler absent.

Beer board changes

Commissioner Gina Oster, who also serves as Beer Board Chair, proposed some changes to the Beer Board that included reauthorizing the board and giving anyone opposed to beer sales a choice not to

The resolution, which saw some discussion last month, passed in a 7-0-3 vote with Commissioners Dailey, Rhonda Lee and Kyle

Ward passing.

More land for parks

The commission voted to accept the donation of two parcels of land from the Appalachian Mountain Bike Club to be added to the county's park system. Commissioner Dailey called on Matthew Kellogg of the club and Park's Director Jim Mack to speak. Mack told the commission the bike club currently has 90 miles of trails in South Knox County. The property is off Prospect Road and McCall



A few days short of my 17th birthday in July of 1964, I rode a train for 77 hours to go to the Republican National Convention that nominated Sen. Barry Goldwater for president.

The convention was held in San Francisco, and I wanted to go by train because at that point in my life, I had not been anyplace west of Nashville.

I was an honorary assistant sergeant at arms, and I have told people since then that you can't get any lower than being an honorary assistant, but it got me into the convention. It was a thrilling trip for me, and I felt lucky to be there.

I felt even more fortunate to still be alive and active and healthy enough to attend this latest Republican Convention 60 years later as a Tennessee delegate.

Susan Richardson Wil-

liams, the Knoxville businesswoman and television commentator, was also part of the Tennessee delegation. As far as we could determine, we were the only ones at the Milwaukee Convention who were also at the San Francisco meeting. Susan was a page at the '64 convention. This year's convention

was a great success and gave a real boost to the party going into the fall elections. There was a very wide variety of speakers, showing the great appeal Republicans have to all people - male or female, white or black, from every walk of life.

We will now be campaigning against the very unappealing Kamala Harris, and I will be doing everything I can to help

re-elect President Trump.



Cont. from page 1 Originally the formula was invented in 1940 by Knoxville beverage bottlers Barney and Ally Hartman. In 1958 a revised formula was created by Bill Bridgeforth. The rights to this formula were obtained by the Tip Corporation of Marion, Virginia, where the formula was further refined. In August 1964, the Mountain Dew brand and production rights were acquired from Tip by the Pepsi-Cola company, and the distribution expanded across the United States

Double Cola hails from Chattanooga in 1933 and was so named because the bottles were twice the size of other cola containers. It was originally bottled by the Seminole Flavor Company.

Johnson City also claims "Dr. Enuf" which was formulated in 1949. It's now bottled by the Tri-Cities Bottling Company there. The drink is different than many other sodas in that it is "enriched with vitamins and minerals" and it was said to relieve muscle aches and pains.

Davy, Davy Crockett

Davy Crockett made an interesting trip to visit his brother-in-law early in the 1800s.

Following the corn harvest in late October of 1822, Crockett had a successful fall hunt saying he found "bear a'plenty and all sorts of game and wild varmints, except buffalo.

"I hunted on 'til almost Christmas, having supplied my family very well with wild meat at which time my (gun)powder gave out."

His brother-in-law had recently settled about six miles away and brought Davy a keg of gunpowder. Although there had been heavy rains resulting in flood conditions Davy decided he couldn't wait longer in going to fetch it. He tied together some extra dry clothes and moccasins and set out.

"The snow was about He had no powder for four inches deep when I started and when I got to the water it looked like an ocean," Davy wrote. "I got in and waded 'till come to the channel where I crossed on a high log."

Crockett then commenced wading again until coming to the deepest part of the river. Ordinarily, he would cross at that point on a log but it was submerged about three feet under the floodwater and couldn't be seen. The water was thirteen feet altogether.

"I felt my way along with my feet on the log although I was about waist deep in was a mighty ticklish business but I finally got over. I had very little feeling in my feet and legs by this time for I was in the water so much."

Crockett continued only coming upon another slough. He felt fortunate however since there was a floating log leading across.

"I mounted the log and started walking across," he told. "When I got about the middle of the deep water, somehow the log spun over and caused me to fall off the log. The water was up to my head. I barely managed to hold my gun and grip above my head.

"I waded out of this deep water until I came to a highland where I stopped to pull off my wet clothes and put on the others. I was so cold my flesh had no feeling. I thought I would run to warm myself a little but I was so cold I couldn't step more than half the length of my foot."

Davy began functioning better after a while and continued the five miles to his destination.

His brother-in-law was amazed to see him upon his arrival. Weather conditions were even worse the frozen to death," he wrote following morning and Davy later in life. "When I mandecided against trying to aged to get home. I wasn't start back home.

"I went out hunting and it. the water," Davy related. "It killed him two deer," Davy worse and colder instead of better. I knowed the water would be frozen over but so I agreed to stay. The next morning was bitter cold but a short distance before I determined to get home to my family or die a-trying. I took my powder keg and hunting tools and started out."

When Crockett reached sheet of ice for "as far as I could see." He started walking across the ice but it broke through with him after only a short distance.

"I took out my tomahawk and broke my way along for a considerable distance. At last I got to where the ice would bear me so I mounted it and went ahead. It soon broke in again and I had to wade till I came to my floating log. It was frozen in by the ice so I knowed it couldn't give me another

fall as it had before." Davy crossed it without difficulty but still had to negotiate the submerged log that was his last obstacle. The swiftness of the current kept the water from freezing so he had to wade across a log with swift water meanwhile up to his waist. He waded first with the powder and then

returned for his gun. "By this time, I was nearly quite dead, but mighty nigh



TIME magazine once described Matthew Mansfield Neely as tall and thin, whose likes included "the New Deal, the C.I.O." and one who loved "purple language and purple suits." The news magazine noted Neely "also loves politics, in which he is a shrewd and practical man." Few politicians demonstrated the flare for the dramatic of Matthew M. Neely. Neely could have just as well be a successful stage actor. Although he delighted in speaking to audiences numbering in the thousands, M. M. Neely disliked crowds and liked leaving just as soon as his speech was finished. From the time he entered Congress in 1913 until his burial in 1958, M. M. Neely commanded center stage in his state of West Virginia and few loved the spotlight more. For quite nearly forty years, Matthew Mansfield Neely was either a congressman, U.S. senator or

a neutral opinion when it came to Matthew M. Neely. That had been true throughout his political career and remained true even in death. When the longtime senator breathed his last, both the bitter and the sweet were publicly in evidence. From the West Virginia Chamber of Commerce came the wintry blast of "no comment" when asked about Neely's passing. The "no comment" managed to speak volumes.

One Republican, when told of the senator's death, exulted "it couldn't have happened to a better man." Some of those likely had felt the lash of Neely's "corrosive tongue."

ry has ever made so many

of West Virginia. Neely to be in public office, and

political comebacks as Matthew Mansfield Neely was one of those who had he was popular enough to come and go with remarkable frequency. One of the most colorful politicians in a state renowned for its oftentimes brutal politics, Matthew M. Neely's longevity in politics and officeholding was only outdone by Robert C. Byrd in the Mountain State. Yet Byrd was entirely a creature of Congress, serving in both the House of

Faithful readers of this U.S. Senate. M. M. Neely served in both houses of Congress as well, but he also was elected governor of West Virginia. Like Robert Byrd, Neely was a colossus in West Virginia's stormy political landscape. Unlike Byrd who never lost an election, M. M. Neely knew both the taste of victory and the despair of defeat. The oftentimes flowery orator of the old school could quote from the Bible, poetry, and Shakespeare equally with ease. Even Robert Byrd never dominated West Virginia politics as did Matthew Mansfield Neely. Neely consolidatenough to elect a protégé to West Virginia's other Senate seat. The head of the "federal" faction of Party, Neely openly sought a candidate for the governorship to eliminate the more conservative "statehouse" wing. None of the prospective candidates

> if his real trade was holding public office, Matthew M. Neely was the champistaunch ally of organized labor in a state heavily populated by mine workers and where coalmining was big business, union. Neely's rise was due in large measure to his phenomenal memory. Even in his eighties, the senator could call people by name whom he had only met casually. While he worked painstakingly on speeches, he was able to read them once or twice and commit them to memory, making it appear to audiences he was speaking

extemporaneously. Neely first came to the House of Representatives in the 1913 special election after Congressman John W. Davis resigned to become ambassador to Great Britain. Reelected in 1914, 1916 and 1918, Neely suffered his first political defeat in the 1920 GOP landslide. Two years later, Neely was the Democratic nominee for the United States Senate held by Republican Senator Howard Sutherland. Neely won the election, only to lose his reelection bid in 1928 to GOP Governor Henry D. Hatfield. Two years later, Neely made a triumphant return to the United States Senate by beating the Republican nominee by the greatest majority given a candidate

for the Senate in West Virginia until that time. With the advent of President Franklin D. Roosevelt and the New

Deal, Senator Neely lavishly

Neely was building a political machine and its effectiveness became clear when he backed Rush Holt against his Senate colleague in 1934. Rush Holt, unable to take the oath of office for six months because he did not meet the constitutional requirement of being thirty years old, defeated Senator Hatfield decisively. By the time Neely came up for reelection in 1936, he and his protégé had become bitter political enemies. Holt, angry that Senator Neely was gorging himself on WPA jobs, took to the Senate floor to denounce West Virginia's senior senator. Holt claimed Neely was attempting to build up a powerful political machine. Holt endorsed a former Speaker of the West Virginia House of Delegates against Neely in the Democratic primary. Neely beat the stuffing out of his opponent, proving his political machine was running both smoothly and effectively.

The statehouse faction was busy dispensing its own patronage throughout the state and creating a formidable machine in its own right. Neely recognized the threat to his continued tenure in the Senate and ran for governor in 1940 and beat the statehouse candidate inside the Democratic

primary. That proved to be the peak of Neely's political potency and power. Neely was even able to appoint his own successor in the United States Senate. Governor Neely selected Dr. Joseph Rosier, a colorless president of West Virginia's State Teacher's College. It was readily apparent Neely had picked a placeholder rather than someone who could run for and hold the seat in the 1942 election. Neely had also managed to replace Rush Holt in the Senate, backing an obscure country judge, Harley Kilgore, inside the Democratic primary. Senator Holt, tarred with the brush of isolationism, ran third in a three-way primary between himself, Kilgore and ex-Governor Kump. It soon became clear Neely intended to

Chapman Revercomb to beat M. M. Neely. The 1942 election was the greatest political surprise of Matthew Neely's long political career. Governor Neely's enemies, Republicans and Democrats, supported Revercomb who beat him soundly. Loathing the idea of life without public office, Matthew M. Neely challenged GOP Congressman Andrew Schiffler for reelection in 1944. Grabbing hold of a frail FDR's coattails, Neely won the election. Two years later, the 72-year-old Congressman M. M. Neely was upset yet again by another Republican. Francis Love won the 1946 election in one of the best years the GOP had enjoyed since the

Seventy-four-years old in 1948, M. M. Neely made his greatest political comeback by challenging and ousting his successor in the Senate, Chapman Revercomb. Matthew M. Neely easily turned aside a serious challenger in 1954 and remained in the Senate until the day he died.

As it became more noticeable that Senator Neely might well be seriously ailing, some Democrats urged Neely to retire before Republican Cecil Underwood took the oath of office as governor. Whoever suggested that course of action must not have known Neely well; public office without Matthew Neely was the duller for it, but without public office, Neely was not whole. seek, knock. Prayer is an action we take. Asking is an action and demands a response at some level. It literally can be read: Keep asking. Keep seeking. Keep knocking. Don't stop. If your kids ask you for something they desire, and you had the ability to provide it, and you thought it reasonable and good, you would get it for them. Why? Because you love your kids.

So, what is prayer? Dallas Williard defines prayer as: "Talking to God about what we are doing together." Prayer is a back-andforth conversation with God. Prayer always centers around relationship and it involves asking. A little boy was going off to bed. He said to his family, "I'm going to be praying to God. Does anybody want anything?" What a great attitude. That boy believed God is approachable with our requests and will answer. Sometimes we pray thinking, "Well, I know He's not going to answer

Asking is uncomfortable for many of us. Pride can get in the way. We are a society that takes great pride in doing things for ourself and consequently we wait until we have about ruined our lives before asking for help. At times, we all need help. No man is an island, despite what Simon and Garfunkel would tell you - "I am a rock, I am an island." Society tells us over and over, "You don't need anyone. To be successful is to not have to ask."

Pride often comes from a place of injury, hurt, or trauma from the past. The root of pride is often fear. In asking someone, we are afraid of rejection. What if we are told no, again? We are afraid of being indebted to someone else.

We don't want to be a burden to others. Asking is a vulnerable thing and you have to come face to face with another person. But relationships are built on asking.

There is a danger in a text like this one, where you read it and suddenly think that God will grant every request we bring to Him by the next day. This unrealistic approach to prayer has destroyed the faith of many and led to resentment and anger toward God. I don't have an answer to why God answers some prayers in the affirmative and other times with a no. What I do know is that we have to rely on both the goodness and the wisdom of God. We might think we know what is best for us and others we care about, but we need to trust that God knows how and when to answer our prayers.



Powell aims for state championship

The more things change, the more they stay the same for the Powell High School football program. The Panthers have one goal and one goal only, as they prepare for the upcoming 2024 season.

The lone objective is to win a Class 5A state championship.

"Our expectation is always the same," said coach Matt Lowe. "Our expectation is always to win a state championship, and if we don't, it's a disappointment.

Bathrooms, pavilion coming to Urban Wilderness Gateway Park

Last Tuesday, Knoxville City Council unanimously authorized Mayor Indya Kincannon's administration to proceed with a planned \$4.6 million Urban Wilderness Gateway Park pavilion.

The 23,000-square-foot structure and plaza will contain four bathrooms, shade structures, a water refilling station, picnic tables, and play features that include slides and climbing areas nestled into slopes, amid natural boulders and landscaping.

The park is strategically located at the southern terminus of James White Parkway, where it ends at Sevierville Pike. The world-class Baker Creek Bike Park, for example, is less than a halfmile from the Urban Wilderness Gateway Park. The area is the nexus to a rich network of more than 68 miles of trails.

"The Urban Wilderness has truly come into its own as an outdoor adventure destination - it's no longer a secret," said Rebekah Jane Justice, the City's Chief of Urban Design and Development.

"With the existing parking and these new family-friendly facilities, the Urban Wilderness Gateway Park will become a true stepping-off point for Knoxville families as they set off on both big and small adventures."

The pavilion project is one of the last pieces of the larger overall Urban Wilderness public amenities plan, first proposed, approved and budgeted eight

Design and Construction Services Inc. was selected as the most responsive bidder for the competitively-awarded pavilion contract, which will be finalized

this summer. The pavilion and other site construction will be completed by late 2025.

In addition, work is continuing on two new greenway segments that - once completed - will better connect the South Waterfront and the Urban Wilderness with downtown, East Knoxville and other points north of the Tennessee River.

"The river, throughout Knoxville's history, has always been a sort of natural barrier," Urban Wilderness Coordinator Wes Soward said. "But soon, that will no longer be the case. We're working to enhance a much safer connection between the Urban Wilderness and areas north of the river.

"The Urban Wilderness Gateway Park will be a natural spot where thousands

of visitors will stop before continuing on to their way to whichever destination they're wanting to explore."

One of the new segments - an extension of the Cottrell Greenway, between the Gateway Park and Sevier Avenue is expected to officially open by this fall. One of two lanes of one-way northbound Cottrell Street is being converted to a greenway. The road has been paved, and next, the multi-use pathway lane will be striped and landscaped.

The other greenway is even more ambitious: It will cross the Tennessee River via the South Knoxville Bridge - a protected greenway on the northbound lane, connecting to the Morningside and James White Greenways. Construction is expected to begin next year on the rivercrossing greenway.
