Annual Suffrage Banquet set for Thursday

The Suffrage Coalition's Annual Febb Burn Banquet and Fundraiser will be held Thursday at 5:30 p.m. at the Foundry in the World's Fair Park. Tickets are on sale for \$104 each, one dollar for each year women have had the right to vote.

In August 1920, Febb Burn wrote a letter to her son, state Representative Harry T. Burn, encouraging him to vote "Yes" on the ratification of women's right to vote. His one vote in favor of the Constitutional Amendment ratified it in Tennessee and, thus, ratified it across the nation.

That letter is held in the McClung Collection. Also housed in that collection are the papers of Lizzie Crozier French, who spearheaded the suffrage movement in Knoxville. In the invitation notice, the coalition asks supporters to "consider helping us in the worthy cause of locating and preserving Tennessee's amazing suffrage history." Plans for the evening include an art show and sale, a silent auction, cutouts of famous Tennessee suffragists, new music by Candace Corrigan, a display of suffrage timeline from 1848 to 1920, and a sneak preview of "one or two items planned for display in the future museum." "A dynamic Suffrage Museum will serve as a resource for teachers, students, researchers and lifelong learners," the coalition said in a promotion. 

On August 12, the U.S. Secretary of State, Antony Blinken, issued a press statement commemorating the anniversary of the adoption of the Geneva Conventions.

He said: "The 75th anniversary of the adoption of the 1949 Geneva Conventions is a fitting occasion to reaffirm our commitment to respecting international humanitarian law ... We call on others to do the same."

Except Israel.

Blinken added: "Faced with the horrible reality of flict must comply with international humanitarian law to mitigate many of war's worst humanitarian consequences, support pathways to peace, and advance the protection of civilians and other victims." Except Israel.

Of course, Blinken did not add the words "except Israel" but he should have, considering what had happened just two days earlier. On August 10, Israel dropped bombs on a school sheltering displaced Palestinians, killing over 100 and injuring hundreds more.

The New York Times reported that one witness "said he found a scene of carnage unlike any he had seen in the past 10 months of war: A prayer hall strewed with bodies and body parts over two floors." Another witness said "the dead were all in pieces."

CNN said there was "no

attack" and reported that the director for ambulance and emergency services said, "All of these people who were targeted were civilians, unarmed children, the elderly, men and women.'

NBC News described the event as "one of the deadliest attacks in the 10-month war" and said the strikes hit the school "during down prayers." The network reported, "The White House said it was deeply concerned." Two days earlier, Secretary Blinken announced that the U.S. was sending billions more to Israel in a new weapons package.

The Financial Times quoted a surgeon as saying, "This was a very bloody day," and that he had performed several amputations including on at least four children.

my old agency, the National Credit Union Administration. When I was there in the early 1980s the agency moved within DC. Years later it moved to Northern Virginia. It did not ask permission of the congress. It just moved. I believe that the credit unions benefited from the move. When I studied the Fed as a young economist, I found that the actions and recommendations of the Fed's reserve bank presidents were starkly different from those of the governors. The difference likely emanated from the reserve bank presidents being located around the country while the governors all resided in the DC MSA. The presidents work and live around people with real jobs while the governors live around those whose existence is due solely to the presence of the federal government. A reserve bank president is more

likely to hear his neighbor

approval. A case in point is talk about the local football game while the governor's neighbor is more interested in the rate of inflation and interest rates. Also, the reserve bank presidents get monthly reports from their directors who are nongovernment citizens bankers, lawyers, academics and business executives - and those reports influence their decision-making. I served as chairman of the Nashville branch of the Federal Reserve Bank of Atlanta and can attest to the impact of the director's reports.

Housing and Urban Development - Philadelphia (part of the most urbanized area in the US)

Transportation - Seattle (home of Boeing)

Energy – Houston

Education - Phoenix (24% of Arizona schools are charter schools)

Veterans Affairs - Bedford, Virginia (site of the D-Day Memorial)

Nondiscrimination policy may change with commission vote

Knox County's personnel plan requires the county to follow Title VI of the Civil Rights Act of 1964 but the county commission may update the language in order to comply with new guidelines issued by the Department of Homeland Security.

The agenda item deletes Knox County Code Section 2-763 which states: " Knox County complies with Title VI of the Civil Rights Act of 1964. This act requires that agencies receiving federal money develop and implement plans to ensure that no one receiving benefits under a federally funded program is discriminated against on the basis of race, color, national origin or limited English proficiency. Complaints must be made in writing or through the online complaint portal. More information regarding Title VI can be found

on Knox County's website"

The new proposal before the commission would replace the language with "Knox County complies with Federal and state civil rights laws and is committed to provide its programs and services without discrimination to members of the public, clients, consumers, program beneficiaries and employees."

The revised language goes on to quote the 1964 act and the other acts in 1972, 1973

and 1975 dealing with discrimination against race, color or national origin, disability, sex in educational programs or activities, age and religion in social service programs.

"It is against the law to retaliate against anyone who takes action to oppose discrimination," the new proposal says, adding, "The complaints must be made in writing and submitted to the Nondiscrimination Coordinator."

Those letters should be

submitted to the Knox County Human Resources Department. Stephanie Candler of that department told The Focus that a "coordinator" has not been named yet but will probably be her or Markus Kennedy. She said the change includes expanded language as required by Homeland Security.

The ordinance will have its first reading at next Monday's commission meeting and two readings are required.



The time for hundreds of panels should be called. Cable news rattles on all day, so stations must find fillers for those hours. Few panelists have credibility like that of John Meachum. Most of the guests are former politicians or television hosts. Viewers want authoritative folks to inform them, not someone whose opinion is more correct than theirs. Several of the hosts have huge followings; others seem to be on the set merely to show how inclusive the channel can be. This is the news we're talking about, and the best individuals should be holding spots at the desks.

The other night, I tuned in to a national news telecast. In half an hour, I heard the biggest stories of the day. If I wanted more discussion of a topic, I could then check out cable news. That short broadcast helped me to recall the great of television journalism: Cronkite, Huntley, Brinkley, Rather, Reynolds, Smith, and Brokaw. Those individuals were reporters and anchors. I can still see Walter Cronkite's face as he reported the death of President Kennedy and as Neil Armstrong took the first step on the moon. He reported the news and rarely let his emotions get in the way. When he did, however, viewers knew how grave or spectacular an event was. We could count on his stories being factual, and whether we liked it or not, "that's the way it was!"

I long for those days of simplistic, truthful news. I hope the cable news networks can get back to it without all the cute tricks and sets and presentations. As another famous television character used to say, "Just give me the facts"

William B. Umstead of North Carolina Pages from the Past


Like Cameron Morrison surprised some when he and Clyde R. Hoey before announced in February of him, William Bradley 1938 that he would not be Umstead served as a a candidate for Congress congressman, U.S. senator and governor of North Carolina. Although both his time in the United States Senate and as governor were abbreviated, many North Carolina historians rank Umstead as one of the Tarheel State's great governors. William B. Umstead was not at all theatrical; quite the opposite. Umstead looked like a smalltown businessman with his horn-rimmed glasses and neat appearance. Umstead was the first person from Durham to serve as governor of North Carolina. Umstead was a man of inflexible rectitude, one who was "a great deal more interested in fighting fair than in winning." Umstead was credited with knowing "as much about the mind and heart of North Carolina as any man of his time."

William B. Umstead taught history for a year before volunteering for the First World War by joining the Army. Rising to the rank of Lieutenant, Bill Umstead fought in France where he served with the 317th Machine Gun Battalion. Like so many of his contemporaries, Umstead attended law school at Trinity College (the forerunner of Duke University). Umstead's first elected ran for a seat in the U.S. House of Representatives. Umstead faced six opponents in the Democratic primary, including one who had the same last name as him. The candidacy of J. N. Umstead was likely intended to siphon off votes from Bill Umstead, who won the primary anyway. Umstead beat GOP candidate William Ward handily, winning better than 67% of the ballots cast. Umstead went to Washington where he served during the first one hundred days of FDR's New Deal. As a member of Congress, Umstead quietly tended to his duties and took care of the folks back home. When he faced a persistent opponent in the 1934 primary, Bill Umstead won the Democratic primary overwhelmingly, carrying all four of the counties comprising North Carolina's Sixth Congressional District by huge majorities. Congressman Umstead beat his Republican opponent with 69% of the vote. After once again dispatching two opponents who had run in the 1932 Democratic primary, William B. Umstead was easily renominated and reelected in 1936, one of the best election years for the Democratic Party in history. Umstead

again that year. Umstead said he intended to return home to Durham and resume the practice of law. Umstead had been one of the steady and reliable Democrats in the House and had been rewarded with a seat on the powerful Appropriations Committee, where he chaired a subcommittee on Naval Affairs, a plum assignment for a coastal state like North Carolina. According to press reports of the time, Umstead had given the bulk of his friends and supporters no warning of his impending retirement from the House of Representatives.

While Bill Umstead did go home and take up his law practice once again, he did not completely divorce himself from politics. Umstead served as chairman of North Carolina's Democratic Party.

Josiah W. Bailey had toppled a political giant when he defeated Senator McLendel Furnifold Simmons inside the 1930 Democratic primary. Simmons had been the head of the most potent political organization in the Tarheel State for quite nearly thirty years. Bailey was a conservative Democrat and led a coalition of more conservative Democrats and Republicans in the United States Senate. By 1946, Josiah W. Bailey was seriously ailing. Senator Bailey was at his home in Raleigh where he was recovering from increasingly debilitating heart disease. The senator still commented on issues facing the Senate while at home. Bailey suddenly became ill in the afternoon of Saturday, December 15, 1946, before lapsing into a coma. Relatives were shocked, as they had noted Senator Bailey had been especially cheerful and had been planning a business meeting. The senator died the same day of a cerebral hemorrhage. As is always the case when a member of the U.S. Senate dies, speculation about a successor began as soon as the incumbent's heart stopped beating. Much of that speculation fell onto the narrow shoulders of William B. Umstead who had managed Gregg Cherry's campaign for governor in 1944. Umstead had only recently resigned his position as chairman of North Carolina's Democratic Party.

Two days after Senator Josiah W. Bailey's death, Governor R. Gregg Cherry announced he had appointed William B. Umstead to fill the vacancy until the 1948 election. Perhaps 24 hours after Senator Bailey's funeral, reporters were ushered into Governor Cherry's office for a press conference. The reporters were given a mimeographed type-written statement announcing Umstead's appointment to the United States Senate. In accepting the appointment, which came with no strings or obligations, Bill Umstead realized he would face a formidable and popular opponent in the 1948 Democratic primary. J. Melville Broughton had left office in 1945 as governor of North Carolina and had been running for the United States Senate ever since. Wisely, Broughton had not sought to move sion to Washington, D.C., by challenging his predeular than Broughton. The former governor, calculating Senator Bailey was too ill to seek reelection, had his sights set firmly on 1948. Melville Broughton had already made it clear to financial backers and supporters that he was a certain candidate for the U.S. Senate. Broughton had anticipated his opponent was likely to be whomever Governor Cherry appointed to the Senate and made the press aware that Umstead's appointment had not altered his plans to run at all. Broughton and Cherry were, if not political enemies, not at all close. Some North Carolina journalists wrote of the Broughton-Cherry "feud," but perhaps a better description was a mutual antipathy on the part of both men. Broughton groused that Cherry, then chairman of the Democratic Party in the Tarheel State, had not supported his candidacy in 1940. As governor, Broughton had forced Cherry's resignation and was silent during the 1944 campaign. Only days before the primary election, an angry Governor Melville Broughton finally broke his silence and endorsed Cherry, but that was only because Umstead had resigned as Cherry's opponent had

Bill Umstead was hardly unknown in North Carolina and had many thousands of friends due to his service in Congress and as chairman of the Democratic Party in North Carolina. Umstead concentrated on his work in Washington and kept in touch with the folks back home. Virtually nobody thought the senatorial battle between William B. Umstead and J. Melville Broughton would be anything but hard fought and close. Umstead also understood North Carolina politics as well as anyone in the state, having managed Cherry's 1944 gubernatorial campaign. Senator Umstead knew who the powers were in each of North Carolina's one hundred counties. Gregg Cherry had likely appointed the strongest contender in William B. Umstead to face former governor Broughton. What had once been thought to be a foregone conclusion had become the hardest political fight of Melville The only saving grace for Broughton was the fact he had begun the race early and had secured commitments from powerful Democrats across the state well before Bill Umstead had been appointed to the U.S. Senate. Broughton won the primary contest by less than 24,000 out of almost 400,000 ballots cast. For Melville Broughton, it was a pyrrhic victory. Broughton was sworn into office on December 31, 1948, and served until March 6, 1949, when he died of a heart attack in Washington, D.C., at age 60. Once again, William B. Umstead was immediately catapulted into the speculation that he would be reappointed to serve in the United States Senate. Having run such a close race against a highly popular former governor, there was little doubt Bill Umstead could hold the seat should Governor W. Kerr Scott appoint him. Umstead was apparently one of the three most likely appointees considered by Governor Scott. Kerr Scott surprised most everyone when he chose Frank Porter Graham, the saintly president of the University of North Carolina, to serve until the 1950 election.

Olive had a commanding presence in the courtroom, accompanied by a powerful voice making him one of the most sought-after lawyers in the state. Umstead won the primary and general elections.

Once elected governor, Umstead startled some of his supporters with the boldness of his proposed program. Governor Umstead said he wanted a bond issue on behalf of public schools and mental hospitals. The governor expanded the State Highway Department from ten to fifteen divisions because it would bring the agency closer to the people it served. When Senator Willis Smith died, Umstead appointed Alton Lennon to fill the vacancy. Later, when Senator Clyde Hoey died, Umstead appointed Sam Ervin to serve in the Senate. Two days after his inaugural address, Governor William B. Umstead suffered a serious heart attack, complicated by severe congestion in his chest, which verged on a case of pneumonia. Rushed to Watts Hospital in Raleigh on January 10, 1953, Umstead did not return to the governor's office until May 21st of that year. The wonder of Umstead's administrations is that he accomplished so much in not only such a short time, but also because he spent most of the 1953 legislative session in bed. The governor governed from his bed. The Greensboro News and Record noted Umstead "was forced to forego many of the nonessentials of the governorship which a convivial state enjoys but which tax the health of a chief executive." Umstead was absent from the routine meet and greet opportunities

Governor Umstead was hospitalized once again in 1954, remaining in the hospital for three weeks before returning to the State Capitol. The governor caught cold, which was severe enough to send Umstead back to the hospital. The cold failed to respond to medical treatment and turned into pneumonia. Governor William B. Umstead died of congestive heart failure and pneumonia on November 7, 1954.

The North Carolina Herald-Sun editorialized Umstead had made a conscious decision to ignore his precarious health to do his duty. The people of North Carolina had elected him as their governor, and he gave it all he had. The newspaper noted the governor's "frail appearance" caused concern amongst those who worked with him, as well as citizens who observed him. The Herald-Sun remembered William Umstead as long before he reached During his short tenure in high public office." The newspaper editorial summarized perhaps that quality which had caused the people of North Carolina to gift him every important office they had to bestow. "There was a consistency in Mr. Umstead's life that people could count on, and behind the exterior that sometimes seemed stern there was a natural simplicity and sweetness of disposition." The Herald-Sun recalled Umstead was incapable of surrendering a principle for the sake of political expediency.

The Knoxville FOCUS August 19, 2024 Two Kinds of Prophets

By Mark Brackney Minister of the Arlington Church of Christ

Jesus said, "Beware of false prophets" (Matthew 7:15). In Jesus' first century Jewish world, prophets took on the role of passing down wisdom of how to live the good life, the life of God. A prophet spoke on behalf of God. The word "beware" is used six times in the gospel of Matthew (6:1; 7:15; 10:17; 16:6,11,12). These warnings are part of a larger theme in Matthew and of the entire Bible. God, Jesus, and the writers of virtually every New Testament book warned about the coming of false prophets and teachers. Some examples: Deuteronomy 13:1-5; Jeremiah 14:14; 2 Timothy 4:3-5; 2 Peter 2:1-3; 1 John 4:1; Revelation 20:10.

When you look at this verse in context, the prior two verses talk about two paths you can choose to walk on (Matthew 7:13-14). One is a destination of life and the other of destruction. A prophet is a guide to help us navigate the journey of life. A godly prophet would help you walk the right path of living in the kingdom of God. A false prophet would point you down the wrong path, a path of ruin and destruction.

Jesus makes it clear that a false prophet is not always easy to notice.

phor: "They come to you in sheep's me, 'Lord, Lord,' will enter the kingclothing, but inwardly they are ferocious wolves" (7:15). This imagery of a wolf in sheep's clothing was not new in Jesus' day. Sheep were the most common form of livestock in Palestine during the first century. Wolves were the number one predator as well. Even today, a wolf is still a figure of speech of someone who is not safe, who is dangerous. A lamb is code word for a weak, defenseless, and innocent individual. Jesus points out that wolves sometimes look like sheep. False prophets don't always look like false prophets. We have to use discernment when listening to those who claim to speak for God.

So, how do you tell a true prophet from a false one.First, there is the life test (Matthew 7:16-20).Jesus says examine the fruit of their lives.Fruit is a metaphor from what comes out of your life - character. What are they like offstage, behind the scene? How do they treat their spouse and kids? Are they arrogant? Are they accountable to anyone? Are they humble? Jesus says, "Look at how they live?" This is what Jesus means by fruit. Good people make more good fruit. Bad people make more bad fruit.

The second way to tell a true prophet from a false one is the teaching

So, Jesus continues with a meta- test: "Not everyone who says to dom of heaven, but only the one who does the will of my Father who is in heaven" (Matthew 7:21). In the Gospel of Matthew, that phrase, "the will of my father who is in heaven" is code for Jesus' teaching. Jesus' teaching is the will of the Father. Jesus would have us look at the content of what people are teaching. To help determine if someone's teaching is good or bad, ask yourself, "Is this person's teaching helping me move closer to Jesus and his teaching or not? Do they make me want to do the will of my Father or are they trying to justify things to make me do what I want to do or hear?" Scripture and the teachings of Jesus must be our litmus test.

> The third way to distinguish a true prophet is the "Do they know Jesus?" test (7:22-23). Jesus is talking about someone who claims to be speaking in the name of Jesus but is not a follower of Jesus. Apparently for Jesus, a good life and good teaching is not enough.Does the prophet have a genuine, authentic relationship with Jesus?Do they know Jesus?May God help us all do the Father's will, bearing good fruit and modeling the good life, a life transformed by the Spirit of God to transform this world.

FROM THE MOUNTAINS BY JADON GIBSON FDR visits the mountains

By Jadon Gibson

Franklin Delano Roosevelt came to the mountains of Kentucky, Tennessee and Virginia with his uncle, Warren Delano Jr. Another uncle, Theodore Roosevelt, was president of the United States at the time.

The young Roosevelt had recently graduated from Harvard when he visited Harlan and Bell counties in Kentucky and Lee County in Virginia. He aided his uncle in assessing titles and surveys for Kentenia Corporation.

"An energetic, collegiate type of fellow, Roosevelt often dressed in a turtleneck sweater with a large H (for Harvard)," an elderly resident recalled several years later. "He got on and off his horse in leapfrog fashion and was busting with energy.

local residents and often stopped Virginia, letterhead. "We arose We then rode about 3 and a half Kentucky, Tennessee and at local stores where they visited Saturday morning at Pennington and exchanged greetings.

"They sat around the pot-belly stove and spun yarns with the local residents. FDR studied the mountain men as they chewed tobacco and spat on the stove causing it to sizzle. After a while, FDR was chewing and sizzling as loud as the old-timers."

Eleanor Roosevelt's book, "This Is My Story," published during FDR's presidency in 1937, included the following from a letter her husband wrote to her during his mountain visit in 1908.

"June 12, 1908. This letterhead is erroneous as to our location as we have come many more miles into the mountains, staying at Mr. Henry Smith's house about three miles from Harlan, "He and his Uncle Warren Kentucky," he wrote on statio-Delano were both friendly with nery with a Pennington Gap,

at 6 a.m. and took the train 18 miles down the valley to Hagen at the station.

"We dropped down into the valley along Catron's Creek and came to the Smith house in the early evening after traveling 22 miles or 23 miles in all. It was the roughest trail and worst road in a county that is famous throughout the land for bad trails and even worse roads.

"Mr. Smith is perhaps the most prosperous farmer of the county and his bottomlands along the valley are splendid. I must close this hurriedly as the mail is going."

In a June 15, 1908 letter FDR penned, "We breakfasted late yesterday at 7 o'clock and sat around for an hour discussing legal and political affairs.

"That was like seven miles anywhere else because of the horriand found horses waiting for us ble conditions of the roads here. This afternoon we rode five or six miles up Martin's Fork which is the most beautiful country we have seen yet. The sides of the valley going up 2,000 feet, heavily wooded with great poplars, chestnuts and a dozen or two other deciduous trees is splendid. Every mile or so there was a fertile bottom with fine crops and a stream of crystal water. Tomorrow we are going to an all day ride up Clover Fork."

Warren Delano Jr. was a vice president of Kentenia Corporation and a director of the L&N Railroad at the time. He was instrumental in getting L&N to build a branch in Harlan County. Kentenia took its name from

Virginia, where it had extensive land holdings. The main offices were in Big Stone Gap, Virginia.

Warren Delano and FDR attended an elaborate dinner celebrating Kentenia's first anniversary.

The menu included shaddocks (the antiquated name for grapefruit), oyster soup, roast turkey with cranberry sauce, baked ham with currant jelly, French peas, potatoes, string beans, asparagus, cornbread, ice cream, cakes and fruit.

The menu also included several types of wine and a cigar for each attendee.

It was a time of excitement and optimism. The railroad was under construction and with each passing day it was drawing nearer to Kentenia's holdings.



More than 70 years ago, the future was on full display on Shields-Watkins Field. Fans might have needed a scorecard to totally understand the situation.

On Nov. 15, 1952, Tennessee (7-1) and Florida (5-3) squared off in Tennessee's eighth game of the season. It was Homecoming Day on campus, with an announced attendance of 32,000, an above average crowd for the early 1950s. It was the first time the two teams had met since 1944. Tennessee won 26-12, in what was Bob Neyland's final win on the home field. The game itself appears to be just another contest. It hasn't attracted the atten-

tion of Tennessee historians Tom Siler, Russ Bebb, and/or Marvin West. In their writings on Tennessee football history, they noted that Florida was under the tutelage of former Vol Bob Woodruff (1936-38) and that Vol fullback Andy Kozar had suffered a career-ending back injury during the game, after rushing for 111 yards and scoring twice. That's about the extent of their coverage.

Woodruff, who would be named athletics director 11 years later, had been head coach at Baylor (1947-49) and would lead the Florida program from 1950 through 1959.
